#### FIGHT FOCA CAMPAIGN

FOCA, the Freedom of Choice Act, is the most pro-abortion legis

lation to be proposed since Roe v Wade was enacted into law 35 years ago. Since that time, nearly 50 million babies have been aborted in the USA. While this law is still in effect there have also been a number of limiting amendments passed at the federal and state level, including restrictions on federal funding, and a restriction on federal funding of abortions in other countries In addition, over 40 states have passed legislation requiring parental consent for their children under 18, restricting late term abortions and protecting the right of conscience for medical care providers and 27 states protect the right of conscience for institutions. In addition over 30 states have banned partial birth abortions or require counseling before an abortion.

FOCA would eliminate all of these restrictions because it would define abortion as a "FUNDAMENTAL RIGHT" and as such it would invalidate all laws in existence which might restrict abortion, would require federal funding, and would define as discrimination any medical practitioner or medical institution that would offer child birth services but not abortions.

The American bishops, at their recent meeting in Baltimore, have condemned this proposed legislation and are advocating that the dioceses and parishes mount an aggressive campaign against FOCA. Bishop Dewane of the Dioceses of Venice has endorsed this campaign and is actively promotng it within his dioceses. Fr. Hugh has asked that the Pro Life Committee of the Our Lady

of Light Council take the leadership role in this campaign. The committee has agreed to take on this role and they have also decided to enlist the help of Our Lady's Society, in this effort. A brief outline of the program is as follows:

- 1) A supply of 3,000 sets of literature consisting of 3,000 educational fliers and 3,000 sets of 3 postcards; have already been ordered.
- 2) The educational fliers provide an outline of FOCA and its implications. These fliers will be distributed at all Masses on the weekend of January 17 & 18
- 3) The 3 card packs, one for each senator and one for our local congressman, will be distributed at all Masses on January 24 & 25
- 4) There will also be announcements in the bulletins and at all Masses
- 5) We will need 14 volunteers for each Mass for each weekend. You can volunteer for the Mass you normally attend but you will have to arrive 30 minutes earlier on the 17 & 18 and stay a little later on the 24 & 25
- 6) We will collect the signed cards at the church in 3 boxes at each entrance, validate that the cards have been placed in the correct container, count, band and label the cards
- 7) The respect life committee will consolidate, label and count all the cards. The cards will be delivered to the dioceses for consolidation with other parishes and the dioceses will deliver all cards for consolidation at the state level
- 8) The combined cards will be delivered in bulk to the two senators and various congressional representatives from Florida.

This is a very important campaign and we need volunteers. We are not asking for a significant portion of your time......but we do need your commitment.

#### In Case of Death

At the death of a Brother Knight, notify the Grand Knight or the next in charge, who will then contact the family and offer sympathy and help from the Council. The Council member contacting the family should ask whether a wake will be held and if so, whether the family would like the Council to do a rosary service. If a Mass will be offered the family should be asked if they would like a resolution of condolence to be presented. Any ceremonial presentation requested should be done only with permission of the clergy. If the deceased Brother is a 4th Degree member, the Grand Knight will notify the Insurance Field Agent and the Faithful Navigator of the Assembly.
