Transferred In: Jocko Scavelli, Kent Schmitt

A motion was made and carried to vote on a resolution stating that approval of the Council 2007-2008 Budget at the September 2007 general membership meeting would give prior authorization by the membership for transfers of funds from the Treasury in excess of the current limits of Article VII. Sec.3 of the By-Laws (\$500). Approval of this resolution would allow transfers of funds from the Treasury to the limits of the line-item amounts in the Expenses section of the Budget without a special vote for approval of each item. Please see attachment to this newsletter for the 2007-2008 budget. A second motion was made to vote on a resolution at the September 2007 general membership meeting to eliminate further contributions to the building fund described in Article VII. Sec. 6 of the By-Laws and to eliminate this optional section from the By-Laws. Funds currently allocated to this account would be reallocated to the General Funds of the Council.
