
From the Deputy Grand Knight

Field Agent's Message: Case in Point:



According to the American Heritage Dictionary. *Legacy is* (1) money or property bequeathed to someone by will; (2) something handed down from an ancestor, predecessor, or from the past. Some people leave their legacy to the church, or to St. Jude's Children's Hospital, or in a trust to make sure their grandchildren og to college. Some have huge dreams for their legacy, some have smaller ones but one thing is for sure, they want to leave a legacy to something or someone. What is your dream? What do you want your legacy to look like? Are you taking the steps to make it happen? I have seen many people that know what they want, and are doing all they can to put it in place, but have not considered all of the implications. For instance, they are building their legacy aiming for that goal without knowing that the way their estate is structured they are leaving a large portion of their legacy to the IRS!

(1) Elvis Presley died with an estate of \$10,165,434, for a king this is modest. After the settlement of his estate his family received \$2,790,799. That's a loss of 73%!!!

(2) Franklin Roosevelt's estate diminished by 30%.
(3) US Chief Justice Charles Evans Hughes—a 35% loss. You'd think he would have gotten better legal advice.

(4) William Boeing (yes, that Boeing) - a 52% loss. True, there are a select few knights in this area that are facing this type of shrinkage because of the estate tax. For the rest of us, we don't have that problem. We have enough to cover nursing and home care bills, and still leave a legacy to our children. The children of the boomer generation will be the first ceneration that will end up worse off than the ceneration preceding it. And not through fault of their own. Of course, some of you may feel that your children are wealthy enough themselves to pay all of your debts (current and future, including final) without having to hold a fire sale--taking huge losses to do so; and, definitely your wife can afford to lose your income and withdraw savings, less taxes, to live for another 10, 20, 30 years.

Life insurance creates, not the probability of a legacy, but the certainty of a legacy; non taxable and for pennies on the dollar. <u>Tax Free Certainty of your</u> <u>legacy</u> is what you and your family get from the Knights of Columbus, whether you live to long or die too soon, or become disabled along the way. Ultra Sound Initiative

We want to inform you of a potential project our council is looking to become involved in, to solicit your input and feedback as to your willingness to support this project in some manner; either working whatever fundraiser we come up with, providing financial assistance, or just providing your ideas for kicking off or abandoning this project. Our council is considering kicking off a project to place an Ultra Sound Machine in the crisis pregnancy center in Immokalee by applying to Supreme for matching funds and starting a fund raiser to get monies necessary to purchase the machine. Studies indicate that up to 90% of pregnant woman considering abortion will choose life after witnessing the pictures of their unborn baby via Ultra Sound. This would be a rather large under taking when piled on our other responsibilities such as the Pancake Breakfasts, various Dinner Dances, Handicap Drive, Golf Tournament, etc., however, it would certainly be a worthwhile project even if it saved the life of only one child. I have along with Brothers Pat Becker and Sean James visited with Diane Hanson Executive Director of the Immokalee Preo-

nancy Center and we believe that her center will qualify for an Ultra Sound Machine under the Knights Ultra Sound Initiative program.

We are told that although these machines retail for \$45,000 to \$50,000, the Knights of Columbus can obtain large discounts bringing the cost down to approximately \$26,000. In order to participate in the program we would need to raise half of this amount and supreme would then match the other half.

We are currently considering two different fund raiser ideas and looking for other ideas. We also believe that if we ask our District Deputy to solicit the other councils in our district to accept responsibility for a portion of the fund raising effort it would make it much simpler to raise the required \$13,000. The two fundraisers that are currently being discussed are; 1.) A raffle for a trip to Rome for three. The reason it is for three is that the person winning will be able to take his/her spouse or friend AND their favorite priest. The fundraiser would require

selling approximately 1000 tickets at \$20 apiece.

2.) A straight fund raiser asking parishioners in the parishes of our district to donate to this worthy cause. The idea is to purchase 1000 to 1200 baby bottles (at \$1.00 apiece) and stuff them with information on the Ultra Sound Initiative and ask them to take the bottles home and stuff them with their spare change, coins and bills and bring them a week or two later. 

In Case of Death

At the death of a Brother Knight, notify the Grand Knight or the next in charge, who will then contact the family and offer sympathy and help from the Council. The Council member contacting the family should ask whether a wake will be held and if so, whether the family would like the Council to do a rosary service. If a Mass will be offered the family should be asked if they would like a resolution of condolence to be presented. Any ceremonial presentation requested should be done only with permission of the clergy. If the deceased Brother is a 4th Degree member, the Grand Knight will notify the Insurance Field Agent and the Faithful Navigator of the Assembly.
